Job Title: MONITORING AND EVALUATION (M&E) OFFICER

Background:

The M&E Officer is required to assist the M&E Specialist of PIU IFRAP Component-1 project funded by World Bank.

Purpose:

The incumbent will be responsible for the monitoring and evaluation of all the projects/project activities run under the PIU IFRAP C-1.

Responsibilities:

- Assist M&E Specialist in development of Monitoring systems in PIU to strengthen project smooth implementation of project.
- Gather Information and produce draft quarterly progress report with support from the other sections' officers on a quarterly basis and present it to the M&E specialist for onward process and sharing.
- Produce quarterly field visit data for all the program staff to ensure adequate field monitoring support to PIU IFRAP C-1.
- Pro-actively participate in PIU monitoring, on-going assessment and analysis of the activities of component-1 of IFRAP.
- Assist the M&E Specialist in conducting relevant/need based studies, and evaluations. This includes assistance in the design of data collection methodologies and research related to project interventions and the introduction of new approaches and methods in project monitoring and evaluations
- Assist in the development of funding proposals and review/finalization of donor reports.
- Compile all field visit reports and share with M&E Specialist
- Provide field-monitoring support to the project activities through project field visits.

- Support M&E specialists in developing, consolidating and implementing fieldwork plans of the PIU, generate and maintain field progress and reports on a quarterly basis in coordination with the relevant sections
